Present Day Crisis Created by Govt's Failure to Tackle Corona Menace

- 4.Arrange sufficient oxygen, ventilators, medicines and beds available to all needy persons.
- 5. Take all private hospitals in govt's hands and make arrangement for people's treatment affordable.
- 6.Provide all poor families Rs.10000 and start community kitchens to provide free meals to the needy persons.
