Bankruptcy of Ruling Classes

To Coverup their Crisis and Failures – Rulers are Under Reported the Corona Fatalities (Deaths)

Capitalist systems and semi-colonial and semi-feudal systems are facing series of crisises corona pandemic is pushing these systems into much more crisis. In the first period of corona, in the America, Trump stepped back to declare lockdown with the fear of economic system of America would fall in crisis. So, once again it is clear that capitalist economies are very week.

People started suffering with hungry, when India cleared lockdown government mere gave free rice to the people and left them to the donor's contributions. People must and should improve immunity to face Covid-19, but people are so far from nutrition food and leading their lives without food and with half meals. Increasing debts, people are forced to suicides, hunger deaths. In the period of Corona government is not ready to take such steps like helping by transfer of cash to the poor and middle class people. On the other side rulers had canceled Rs. 67,000 crore debts of corporate.

CMIE (Centre for Monitoring Indian Economy) survey statistics revealed that in the period of corona rural areas unemployment rate have increased from 7.9% to 14.34%, Urban areas' unemployment rate had increased from 11.72% to 14.7%. NSO (National Statical Office) stated that in the country the GDP had fell down by 8%. Ajeem Premji University stated that another 23 crores of people had been pushed into below poverty line.

Corona patients heavily faced the scarcity of beds, oxygen and medicines, because of government did not provide basic facilities of health system left to private sector it resulted to lakhs of corona deaths. Private, corporate hospitals exploited the corona patients.

They fetched I lakh per day. Minimumly they collected 6 to 15 lakhs rupees from each patient. Apollo hospital of Hyderabad gave a estimation bill, amount 23 lakhs to a corona patients (serve), from the total amount for accommodation – 4 lakhs 20 thousand, for investigation – Rs. 4,90,000 for medicines and consumables Rs. 11,50,000 for equipment Rs. 1,40,000 professional charges Rs. 90,000.

According to medical experts, if ventilator bed, Remideciver, Oxygen etc. used the bill does not exceed Rs. 1 lakh to 2 lakhs. But the Remidesivar is being charged 3rd of the total hospital bill, thus remidesiver black marker is going on. Special fee for doctors is up to Rs. 50,000 to Rs. 90,000, for oxygen instead of Rs.5,000, Rs. 30,000, for city scan instead of Rs. 3,500, Rs. 30,000 are being charged. Ambulance charges are up to Rs. 1 lakh. There is no implementation of Arogya Sree Scheme for corona, but it announced.

If full payment was not done there was the threatening of treatment would be held. Treatment become deadlier, disease is not. Online payment should not be allowed. Only cash payment should be done. Such illegal methods are being adopted. In the controlling such type of exploitation government are putting responsibility on each other in vaccinating for all people, for escaping their responsibility. It shows their irresponsible attitude.

As on May 21st central health department announce corona fatalities were 2.91 lakhs in the country, the estimated (actual) statistics were different, that were more than 10 lakhs stated by prominent English weekly magazine "The Economist". It also stated that worldwide corona fatalities were estimated approximately from 71 lakhs to 1.20 crores. Accordingly to world meter –up to then 34 lakhs were died of corona, world wide.

As on May 24th Indian govt. said that corona cases for 2.39 crores, corona fatalities were 3.07 lakhs in India. Highest corona fatalities

were incorporated in India after US and Brazil. "The Newyork Times" News magazine collected the information of actual situation in the field and declared that if actual situation in the field and declare that if actual fatalities were more than 26 times of official reports, than corona cases were estimated to 70.7 crores, corona fatalities were estimated to 42 lakhs. Dr. Raman Lakshmi Narayanan (Director of Centre for Disease Dynamics, Economics and Policy) supported the above statistics.

In May 21st world health organization stated that seems to be all the countries of the world under reported the corona fatalities.

Indian rulers' pro-policies of imperialist, comprador bourgeoisie and feudal forces pushed the agriculture, industrial, educational, health sectors into the crisis. Thus they dig their pit.

When corona pandemic pushed the depth crisis of this exploited system into the much more crisis, the ruling classes coming forward with conspiracies, plots to defend and stand the present exploited system. In the part of the, in our country in the countries of the world, governments under reported the fatalities of corona. By under reporting corona fatalities rulers are trying to cover-up their crisis and failures. Peasants, worker and people of all sections should understand the ruling classes conspiracies and plots, expose them and faced them to their consolidation to solve the immediate and long term problems of the people, all classes of the people should be ready for immediate and long terms struggles.
